- Fact sheet prepared on what it is the Council is headed for to be presented to the Governor
- Define the Council's mission on what a model juvenile justice system means, as well as, defining what is meant by the vision and bringing what is necessary to accomplish both (i.e. available resources)

- Dollars need to follow the kid not the court their in, should be a way to have the dollars flow to the kids in municipal and circuit court
- Need to have a plan to offer an alternative to detention that is applicable to all courts in Wyoming

- Need to ensure we are working with evidence based/best practice programs with folks that are properly trained and/or educated

Beth Evans presented regarding compliance and legislation – handouts

HB 35 allows juveniles to 18-20 to serve alcohol and drink it in the presence of their parents in their house

SF 70 they can serve alcohol, but not mix it

HB 256 illegal drug law initiative gives money to the A.G.'s office to prosecute illegal use of substances 1,000,000 million for probation services for youth that are in need

SF 147 is the bill in which the Council is sponsoring regarding status offenses which will not pass this year

Next on the agenda is Joe Evans with the Wyoming County Commissioners Association (WCCA) and the compliance grant

 Since June 06 this grant has been under rework for funding with the Feds and is now able to move with the new plan. In addition, since that time the WCCA was able to hire someone to do compliance

- The three counties with the most violations regarding compliance are Laramie, Campbell, and Sweetwater
- The non compliance grant is 1.2 million dollars over 2 years

Upon adjournment Chair Ric Paul showed the Council a brief video regarding youth and the importance of literacy
