Children's Mental Health Waiver Program – Acts as a diversion tool for children and youth with serious emotional disturbance (SED) and is an alternative to in-patient hospitalization. The Waiver is a Medicaid program that utilizes the wraparound process to support home and community based individualized services and support based on unique strengths and needs of children and youth with SED and their families - should <u>not</u> be used to stabilize children in a crisis situation. Participants must meet clinical and financial eligibility requirements,. Waiver services are available in all counties. Psychiatric Residential Treatment Facilities (PRTFs) – Provide in-patient hospitalization to children and youth with the most serious mental health disorders, average length of stay 3-6 months, include St. Joseph's, Normative Services Incorporated (NSI), Wyoming Behavioral Institute and Yes House.
