

2023 SACJJ Activities

January 2023

- Meeting location Cheyenne, WY
- Elections were held and the following members were elected/or retained roles: Damon DeBernardi - Chair, Erica Wood - Vice-Chair, Nicole Hauser, Abbey Kercher and Melinda Cox - At-Large members of the Executive Committee. The SACJJ learned of the HB009 Juvenile Courts-Concurrent Jurisdiction Clarification that was introduced to the Legislature as well as SF 00094 Federal Indian Child Welfare Act Task Force. Department of Family Services (DFS) discussed their Federal Child and Family Services Review (CFSR) set for the end of the year. The Data Committee worked on collection of information pertaining to the Juvenile Risk Detention Assessment Tool in collaboration from counties all over the State of Wyoming. There was a CJSB (Community Juvenile Services Board) Reform Brief document disseminated to the CJSB's and SACJJ from DFS. The idea was proposed that SACJJ learn and partner with other State Advisory Councils pertaining to juvenile justice. There was emphasis for communities that have CJSB's making efforts toward preventative services of WY Home Matters Initiative. Other topics of discussion included but were not limited to: CJSB Reform, Juvenile Risk Assessment and CJSB Funding. The SACJJ heard an update from the Governor's office and a Budget Report update.
- Community Participation: The SACJJ heard from Laramie County Department of Family Services (DFS) and the Laramie County Community Juvenile Services Joint Powers Board. Learned the levels of intakes are starting to return to prepandemic levels with increased filing numbers, with an increase in CHINS filings. A barrier in Laramie County was struggling with being able to provide mental health services for juveniles within the community, and retain staff in this field of work. They shared they are missing a group home. It was shared Laramie County has focused on family- team meetings.

April 2023

- Meeting location Douglas, WY
- The SACJJ needed to determine a new Chair, as Damon DeBenardi was unable to retain this position according to government rule in SACJJ bi-laws and his change in his position to the Sublette County Attorney's Office. A new chair was elected and that being Logan Christie. During this meeting the individual committees were tasked with reviewing their Strategic Plan objectives and begin planning for 2024. An Order WRCrP-33.1, often referred to as the 14 Day Ruling was discussed and it is perceived as negatively

impacting the processing of citations and charges in communities. This rule essentially states that all citations issued must be filed within 14 days of issuance, and if this does not occur then the citations shall be dismissed Further assessments will need to be determined in each community how/if this ruling is impacting their communities. The topic of adding national juvenile justice topics to the meeting was agreed upon. Membership requirements were revisited. DFS shared that the CJSB Reform efforts are gaining traction. Platte County has submitted an application to be considered for CJSB agreements. In collaboration with WASCOP, SACJJ Data Committee created a spreadsheet that will be used to start collecting information to determine if the JDRA is a beneficial tool to law enforcement. A new member orientation was held for new members. Jennifer Palser was chosen as the new chair for the Best Practices Committee. New Recruitment fliers were completed and presented to the SACJJ for selection. DFS presented an update of the CFSR and the efforts toward this project. DFS also provided information on the Case Management System known as WYOSAFE and where they were in the implementation of this process. Discussion was held to see how the implementation of the new WYOSAFE and data collection applies to SACJJ 2023 Annual Report recommendations. The recommendations were as follows: Community Juvenile Services Boards (CJSB) funding being restored by the Wyoming Legislature, juvenile justice to continue to be a topic with the Joint Judiciary interim committee with the Wyoming Legislature, collection within the juvenile justice system in Wyoming, Wyoming to maintain its non-participation status with the Juvenile Justice and Delinquency Prevention Act (JJDPA) within the Office of Juvenile Justice and Delinquency Prevention (OJJDP), and funding for mental health services in all counties. The SACJJ heard an update from the Governor's office and a Budget Report update.

- Community Participation: Converse County DFS and Converse County Attorney: Charges in this community consist of ongoing substance related issues, concerns appearing at a much younger age, and some firearm related charges.
- Community Highlights: Community Representative Tomi Strock was present and communities' entities were able to provide information on charges within their community.

June 2023

- Meeting location Rock Springs, WY
- SACJJ's strategic plan was reviewed for 2023. Jennifer Palser resigned as the Chair position of the Best Practices committee, and in Jennifer's time as Chairperson, this committee had started a repository of information. Later in

the meeting Alan Stuber was determined to be the new chair of the Best Practices Committee. In prior years the Grants Committee would have reviewed the Non-Participating State (NPS) from ODJJP. Given this has not been an award available since the Volunteers of America (VOA) were former recipients of the award it was discussed should it become available in the future if there were interest parties to pursue the dollars. It was shared that if it did become available again it was beneficial to youth in the community and that the SACJJ would support it being applied for in the future. The Wyoming Survey and Analysis Center (WYSAC) had planning on applying for the The Grant solicitation for the NPS grant once it had been released. Committee shared they would continue to collaborate and review the conditions of this award if/when it became available. Wyoming Statute § 14-10-101 was reviewed and compared to the membership in the Council and it was determined that SACJJ is still meeting the statutory requirements under this Statute. The 14 day ruling was briefly discussed. A contact list was being drafted for other Wyoming State Councils. WYSAC shared they are moving forward with partnering with CJSB's and executing agreements to they can share juvenile justice data. An article was shared pertaining to national news of mentioning how systems in some states push juveniles into institutions where they face higher rates of abuse. Another article mentioned fees and fines may push at-risk youth deeper into the system due to their inability to pay. The Federal Indian Child Welfare Act (ICWA) court decision was drafted. DFS has been seeing more and more juveniles that were in the juvenile justice system rolling into the adult protective services area. The SACJJ heard an update from the Governor's office and a Budget Report update.

- Community Participation: Sweetwater DFS, Sweetwater Juvenile Probation, and Sweetwater CJSB, Sweetwater County Attorney. Substance use is the largest offense in their community. A struggle in their community is providing services to adolescents who are charged with sex offenses, and families are having to travel to other States such as Utah to get services. It was supported by the Sweetwater County Attorney substance related offenses is their larger offense category. Although, the numbers have not rose to the levels of 2019, the numbers are increasing.
- Community Highlights: The community collaboration and integral data from this community is a strength. Sweetwater has a pre-Court Diversion program.

September 2023

- Meeting location Jackson, WY
- Topics that were discussed include 2023 Annual Report Recommendations and create 2024 Strategic Plan objectives. Discussion ensued to amend the SACJJ Statute §14-10-101. A 14-Day Filing document was determined to be

created to reflect efforts made by SACJJ to reach out to community stakeholders in juvenile justice and how this decision is impacting the operations. A presentation was provided by the Wyoming Council Department of Workforce Services (DWS) to the SACJJ. It was shared there are several programs that youth are eligible for. There was discussion if the DWS could collaborate with local CJSB's in the existing communities that are shared. There was a new federal contact for the Office of Juvenile Justice Delinquency (ODJJP). There was noted concerns of juveniles that have behaviors that at times make it harder to find local placement options for juvenile. Council membership was appointed to meet the government and non-government ratio within the requirements of SACJJ. An update was provide that CJSB contracts had been executed except Laramie County. There was a meeting being arranged with the new Wyoming Sheriff's and Chiefs of Police (WASCOP) Director for future reform efforts. Other areas CJSB Reform Discussion, and Juvenile Assessment for CJSB Funding. The SACJJ heard an update from the Governor's office and a Budget Report/Grant update. Additional discussion occurred involving the Budget and Interstate Compact for Juveniles (ICJ). Committee updates occurred, and a presentation was being created for the New Member Orientation by the Youth/Outreach Committee. The Legislative Committee discussed starting the process of amending Wyoming State Statute §14-10-101. Other bill areas that were discussed were the current legislative discussions of Delta-8 Tetrahydrocannabinol (THC) a controlled substance and consent to tobacco cessation programs. DFS shared a recent third-party study on providing rates for DFS placements, although not 100% participation, DFS still was able to get provider rates for preliminary analysis. Reemphasis on efforts involving application of the Indian Child Welfare (ICWA) and CSFR.)

- Community Participation: Teton County DFS, Teton Youth and Family Services,
 Teton County CJSB, and Teton County Attorney's Office.
 - A tour was held for community and SACJJ members to see the new construction project of the Teton Youth and Family Services in Jackson, WY. Teton County has many services. One is the Van Vleck House who offers crisis shelter as well as group home services, Red Top Meadows as well as the Hirschfield Center for Children. The Hirschfield Center offers forensic interviews of children who DFS has suspected the child has been a victim of abuse. This same center also offers a Court Diversion Program and proactive intervention services for families at risk of child abuse or neglect. Teton Family Juvenile Services CJSB supports Camp P.O.S.T.C.A.R.D. This camp works toward increasing positive relationships with law enforcement.
- Community Highlights: Jackson, WY has community mental health center, as well as adolescent substance abuse providers and sex offender treatment programs in the areas that aren't available in other parts of the state.

Extensive collaboration within agencies is important and this includes Multi-Disciplinary Team (MDT) participation. Teton County Attorney shared there is a six-month review for juveniles in out of home placements. One area that was discussed was the efforts seemed to be made by Teton's County's willingness to change for juvenile's need as opposed to the juvenile needing to conform to fit the program that is offered.

November 2023

- Meeting location Casper, WY
- The SACJJ reviewed the plan for gaining information for the 14 day Further discussion occurred to determine new 2023 SACJJ recommendations. Areas that SACJJ found necessary as continued Priority areas were: Continued funding for mental health access for children, further discussion involving JDRA processes, and shortages in staffing and work shortages are deeply impacting communities. Continued collaborative efforts in communities will be vital to work together for solutions. It was discussed further examination of why communities are struggling with rebounding and collection of data for the State stakeholders. Other topics discussed were the CJSB programs and their status toward identifying data collection contracts with ReRoute with WYSAC or other alternatives for data sharing, and possible barriers around that. The Governor's office shared the efforts that are in place with the Governor's Mental Health Initiative, including summits and other information, and 988 and new features involving this hotline. SACJJ learned of the Town Hall meetings that are being held from the Governor's Office. Other areas that were discussed were that Post-vention that was shared is Gillette's beginning a Pilot Program for Mental Health Program.
- Community Participation: Natrona County DFS, Natrona County CJSB A tour was held at the local Natrona County Juvenile Detention Center for SACJJ members. Natrona presenters shared caseloads are up, placements have increased, higher levels of care are necessary. There has been an increased level of felony level offenses and they have been impacted from the loss of dollars as a community. The desire to keep students engaged around truancy issues and expulsions is a large effort in this community. Mercer House provides a variety of services to families. Natrona County has an inpatient facility WBI in their community. Concerning treads that were shared were juveniles with weapon related offenses, gang related activity, rates of females offending is increasing, and the lack of mental health providers/placement/resources.
- Community Highlights: Natrona County explores as many funding alternatives as possible. They have a Family Resource Center. Natrona County has a wide range continuum of care: Pre-Court programming, Youth Diversion,

Community Service, Big Brothers Big Sister Program, Youth Crisis Center, WBI and telehealth services, Pre-CHINS and the Mercer Family Resource Center. Natrona County is collecting data in Juvenile Justice.

2023 SACJJ Recommendations

Based on community feedback, and statewide visits, the State Advisory Council on Juvenile Justice has developed the following recommendations:

- Funding for mental health access. Every community visited shared the barriers they experience regarding access to care. Communities shared the level and need for care of juveniles is increasing and the availability of services is insufficient. Juveniles that require placement has posed an extreme challenge in Wyoming. The limited amount of known refunded provider costs, limited placement options, lack of programming, and vastness of locations for these alternatives are all a concern. It may be prudent to determine better means of access for persons requiring the continuum of care.
- Staffing and Workforce shortages. SACJJ has partnered with other Wyoming Councils such as the Workforce Council in efforts to learn areas that have staffing issues and are impacting juveniles in communities. Both DFS and the Cathedral Home are experiencing staff shortages, as well as local communities.
- Funding to Community Juvenile Services Boards needs to be continued. These monies provide valuable services in communities that allow for them to meet the needs of juveniles within their own areas, providing for a continuum of care that is local.
- Juvenile Justice should remain a topic for the Joint Judiciary Committee. Juvenile justice issues and reform should be a priority for the state. Investing in effective juvenile justice systems not only safeguards the wellbeing of young individuals but also fosters safer communities by addressing root causes of delinquency and providing opportunities for positive behavioral change.
- Data collection within the juvenile justice system. The Wyoming Statute 14-6-606 to collect juvenile justice data was passed by the legislature in 2021. The SACJJ, continues to collaborate with DFS, CJSBs, WYSAC (Wyoming Survey and Analysis Center), and other stakeholders working on a data collection system, developing ReRoute as a bridge to a permanent system. Those efforts need to be continued to be supported by the Governor's Office and the Legislature. Many communities are rebounding and working toward becoming re-established in many areas including programming and data collection. These efforts need to be expanded to prevention and juvenile justice involvement efforts, as well as treatment interventions. Although data collection must be a priority, there are no incentives for communities to attempt to collect and submit data. DFS, WYSAC and Community stakeholders along with SACJJ are working to

create a cohesive and collaborative data collection system.

- Wyoming remains a non-participating state with OJJDP. With VOA of the Northern Rockies no longer managing those funds for the state, it is critical that another agency is identified to ensure our communities receive that funding resource. To date, WYSAC has completed an application for applying for funding and should be supported in their efforts to seek community engagement. The SACJJ strives to work as a grant steward for distribution of funds with the awardee. Helping communities meet the standards of the OJJDP as effective juvenile justice is a continued goal of the SACJJ.
- Collaboration of advisory groups. To ensure maximum understanding and access to state resources, we recommend that on an annual basis executive committees of all state advisory groups meet to share information and resources.
