RE: OJJDP Nonparticipating State Award Update

2007 Nonparticipating State Award

Reported that VOA's grant cycle runs from October 1, 2007, through September 30, 2009.

- Received one request for money from Teton County. Otherwise, counties have not indicated that they
 intend to utilize 2007 monies until after the Wyoming County Commissioners Association's grant period
 ends March 31, 2009.
- Utilized by counties primarily to cover program costs for alternatives to secure detention, to fund secure detention expenses, and to address transportation needs.
- Distributed the first round of tribal passthrough dollars to the Wind River Tribal Youth Program.
- Asserted that Debby will be conducting compliance monitoring in Spring 2009.
- Added that we have developed an Action Plan that Julie Herr is reviewing. Would be vital to collaborate
 with the SACJJ.
- Conducted initial meeting with Campbell County on January 23, 2009. Received a positive response.
 Identified some potential short-term solutions to their Deinstitutionalization of Status Offender (DSO) and Jail Removal violations. Will follow up as necessary. Unfortunately, Campbell County reported that they are now looking at a June 2009 opening of the juvenile wing in their detention facility.
- Reported that we will be conducting similar meetings in other counties in the upcoming months.

2008 Nonparticipating State Award

- Reported that the grant period runs from October 1, 2008, through September 30, 2010.
- Announced that OJJDP approved our 2008 budget on January 30, 2009.
- Provided Assessments.Com update.
 - Will fund two full years of this service.
 - Year 1: March 1, 2009-February 28, 2010.
 - Year 2: March 1, 2010-February 28, 2011.
 - By doing so, will fund this service beyond the end of the 2008 grant cycle to avoid future problems.
- Clarified that VOA will incorporate 2008 activities in our Action Plan.

Judicial Training Update

- Noted that VOA will conduct judicial trainings in Cheyenne, Cody, Rock Springs, and Sheridan.
- Added that we are planning to hold the trainings in Spring 2009.
- Reported that we will be establishing tentative dates for these trainings in the next two weeks.
